Councilman Polhemus moved to do so, seconded by Councilman Jessup. The motion carried unanimously.


Mr. Luna asked for a motion to adjourn to Executive Session to discuss a tax certiorari from Con Edison.

### NOTICE OF PUBLIC HEARING


