**NOTICE OF PUBLIC HEARING ON THE PRELIMINARY BUDGET FOR THE
TOWN OF LA GRANGE FOR THE YEAR 2014**

NOTICE IS HEREBY GIVEN that the Preliminary Budget of the Town of LaGrange, Dutchess County, NY for the fiscal year beginning January 1, 2014 will be completed on October 23, 2013 and filed in the office of the Town Clerk, where it will be available for inspection by any interested persons during regular office hours; 8:30 a.m. until 4:00 p.m. on all business days, except Tuesdays when the hours are between 8:30 a.m. and 3:30 p.m. The Town Clerk's office is located at the LaGrange Town Hall, 120 Stringham Road, LaGrangeville, New York, 12540.

FURTHER NOTICE IS HEREBY GIVEN that the Town Board of said Town of LaGrange will meet and review the 2014 Preliminary Budget Preliminary Budget which includes Water and Sewer Rates for 2014, and hold a public hearing thereon at 7:00 P.M. on October 23, 2014 at 120 Stringham Road LaGrangeville, New York; and that at such hearing any person may be heard for or against the Preliminary Budget as compiled, or any item or items contained therein.

AND FURTHER NOTICE IS HEREBY GIVEN pursuant to Section 113 of Town Law, that the following are proposed yearly salaries of Town Officers of the Town: Supervisor - \$61,000; Councilmen – 4 @ \$8,000 each; Town Clerk - \$52,423; Receiver of Taxes - \$51,537; Superintendent of Highways - \$79,199; and Town Justice – 2 @ \$24,000 each.

All citizens attending the public hearing have the right to provide written and oral comments concerning the entire budget.
