2026 Request for Proposal Fireworks Display at Community Day

GENERAL INFORMATION

1. **The Location:** Freedom Park, located at 212, Skidmore Rd, Pleasant Valley, NY 12569. Park is approximately 90 acres. Fireworks location is open, grassy area with access for box truck.
2. **Event Date:** Saturday, June 13, 2026.
3. **Time:** The fireworks show is scheduled each year for a 9:40pm start. Length of show should be 20 minutes of continuous shooting. Any deviation from said hours must be approved by the Parks & Recreation Director.
4. **Insurance*:** The fireworks agreement will include an indemnity/hold harmless clause providing that the contractor will indemnify the Town of LaGrange, its officers and employees and hold them harmless against any claim or action arising out of the contractor's operation of fireworks display. The contractor shall provide the Town of LaGrange Certificates of Insurance in not less than the following amounts with the Town of LaGrange named as additional insured:
5. ***See insurance attachment for all requirements.**
5. **Permits:** The fireworks vendor shall obtain and produce all the necessary permits prior to event. All paperwork should be sent to Parks & Recreation Director.
6. **Staffing:** The fireworks vendor will provide all appropriately trained staff to set up and run fireworks display. Also responsible to clean up immediate area of show.
7. **Display Cost:** The Town of LaGrange will pay \$5,000 for fireworks display.

FORM OF PROPOSAL:

1. Sealed proposals must be received no later than 10:00am on Tuesday, February 17, 2026, by the Town Clerk at 120 Stringham Road, LaGrangeville, NY 12540, at which time they will be opened and read publicly in the court room.
2. Proposals should include the following: experience and qualifications, proposed fireworks display details, certificate of non-collusion, and references.
